



## REGULATIONS EDP Pela Vida

### Article 1

#### General information

1. These Regulations govern the holding of the "MIMOSA – Corrida Pela Vida" event in the city of Lisbon.
2. Compliance with the provisions of these Regulations does not exempt the subsidiary application of applicable state legislation and sports regulations.
3. MIMOSA – Corrida Pela Vida is organized by MARATONA CLUBE DE PORTUGAL (hereinafter MCP), with headquarters at Av. João de Freitas Branco, 10 Laveiras, 2760-073 Oeiras, Portugal.
4. The MIMOSA – Corrida Pela Vida will take place on May 11, 2025, starting at 10:30 am. This race has the support of the Lisbon municipalities, as well as other official entities.

### Article 2

#### Course and duration

1. The MIMOSA – Corrida Pela Vida is a 5,000-meter, charity race.
2. The MIMOSA – Corrida Pela Vida will have a time limit of 2h00m.

### Article 3

#### Start, route and finish

1. The start will be in Santos (at the back of the "Kais" Restaurant), continuing in the direction of Belém along Rua Cintura do Porto de Lisboa, passing under the Av. Infante Santo viaduct, continuing along Av. Brasília, to the "Vela Latina", then continuing in the direction of traffic to the Belém Tower, where the finish line will be located.
2. The route will be in accordance with the map published on the race's official website [www.maratonclubedeportugal.com](http://www.maratonclubedeportugal.com).

### Article 4

#### Timing and starter boxes

1. There will be no starting boxes at MIMOSA – Corrida Pela Vida.

### Article 5

#### Aid Stations



1.The organization will set up an official aid station at km 2.5, but this does not mean that other stations will be provided at duly marked locations.

## **Article 6**

### **Registrations**

- 1.Registrations must be made online on the race's official website at [www.maratonclubedeportugal.com](http://www.maratonclubedeportugal.com)
- 2.There will be a maximum limit of 15.000 (fifteen thousand) participants in the MIMOSA – Corrida Pela Vida.
- 3.Without prior notice, the organization may at any time suspend or extend the deadlines or add to or limit the number of entries for the competition and according to technical or structural availability.
- 4.Athletes over the age of 8 (eight years old) are allowed to register and take part.
- 5.Entries are personal and non-transferable.
- 6.All requests for changes to registration must be made no later than 1 (one) month before the date of the MIMOSA – Corrida Pela Vida, by emailing [info@maratonportugal.com](mailto:info@maratonportugal.com)
- 7.All participants wishing to take part in the MIMOSA – Corrida Pela Vida must ensure that they meet the health conditions required for the effort inherent in the race, by signing the Term of Responsibility set out in Article 23 of these Regulations.

## **Article 7**

### **Registration and participation of visually impaired and mobility-impaired people**

- 1.To guarantee respect for the principle of equality (non-discrimination) with regard to the participation of disabled athletes, regardless of the category of disability and athletes with reduced mobility, it will be possible for people with reduced mobility who use a wheelchair to take part in the Race, provided they are assisted/pushed by a third party.
- 2.Without prejudice to the provisions of article 27 of these regulations, there is no limit to the number of places available for participants with reduced mobility who need to use a wheelchair, if they are not assisted by any mechanical aid (handbikes).
- 3.For safety reasons, participants using a wheelchair must be accompanied by a person (to be indicated by the participant).
- 4.The registration of this person or guide must be done at the same time and in conjunction with the registration of the participant who will be using the wheelchair, on a separate form, and is not subject to any fee or consideration.



5. Participants with reduced mobility who need to use a wheelchair will leave at the end of the Race.
6. To receive the official Race medal at the end, the disabled participant must complete the entire Race.
7. Visually impaired participants have the right to take part in the Race with a guide, on presentation of a medical certificate of multipurpose disability equal to or greater than 60%.
8. Visually impaired participants and participants with reduced mobility who need to use a wheelchair must register exclusively by emailing [inscricoes.pdvmc@maratonaportugal.com](mailto:inscricoes.pdvmc@maratonaportugal.com)
9. The MCP will not be held responsible for any registration of visually impaired or mobility-impaired athletes, with the need to use a wheelchair, made by any means other than through the email address provided above for this purpose, such registrations being considered invalid and reserving the right not to authorize the participation of the athletes in question.
10. No entry fee will be charged to visually impaired or mobility-impaired participants who require a wheelchair.
11. Participants with reduced mobility and who need to use a wheelchair will be informed, after registering for the Race, how to proceed to access the start area. For reasons of safety and logistical feasibility, it will have to be agreed in advance and authorized by the MCP how these participants will access the start area.
12. Any participant in a wheelchair who arrives at the start area of the Race without prior authorization from the MCP may be refused participation in the Race.

### **Article 8**

#### **Registration fee**

1. Registration fees are set annually by the Organization.
2. Visually impaired participants and participants with reduced mobility who need to use a wheelchair, as well as the guide and assistance team, are exempt from the registration fee.
3. Payments must be made through the means indicated by the organization.

### **Article 9**

#### **Participation Kit**

1. The "Participation Kit" will be given to you when you collect your bib and will contain:
  - a) A T-shirt (5 sizes, the stock of sizes being distributed according to availability).In the event of a stock-out in any size, the athlete will be offered another size;



- b) A bib;
- c) A chip: only for participants in the categories mentioned below:  
Elite (women's individual elite category and men's individual elite category) Team prizes (entered on the appropriate form in the collective prizes: "Vodafone Mãe e filha" prize, "CME 3 Amigas";  
Individual athletes who expressly request a bib and chip (via e-mail and up to a maximum of one month before the date of the race)
- d) An individual equipment bag;
- e) Other gifts and information from sponsors.

### **Article 10**

#### **Collection of participation kit**

1. Duly registered participants will be able to collect their bib and respective "Participation Kit" at the Centro de Congressos de Lisboa on May 9 and 10, 2025, and no documentation of any kind will be distributed on the day of the competition. No kits will be handed out at any time other than those specified above.
2. To collect the bib, you will need to present the respective receipt, which serves as proof of payment of the respective registration fee, or the printed document of the online registration, as well as the identification document of the respective athlete.
3. In the case of disabled/mobility-impaired participants who require assistance from a companion, it may be the latter who collects the bib and respective "Participation Kit".

### **Article 11**

#### **Bib number**

1. The bib is personal and non-transferable and may not, under any circumstances, be reproduced, replicated, or modified, and its use by a third party will result in their disqualification and suspension from participating in subsequent editions of the race.
2. The race bib, which contains an electronic chip, will be the participant's identification and must be attached to the chest area.
3. The Organization recommends that all participants fill in their personal details on the back of the bib for reasons solely related to the participant's own safety, as they may be of the utmost importance in the event of an accident, physical indisposition, or any other emergency during the course.
4. Participants without a bib will not be allowed on the course.

### **Article 12**

#### **"Special VIP" bib**



1. "Special VIP" bibs will not be awarded.

### **Article 13**

#### **"VIP Start" bib**

1. "Vip Start" bibs will not be awarded.

### **Article 14**

#### **Disqualification of MIMOSA – Corrida Pela Vida**

1. Without prejudice to other causes provided for in these Regulations, athletes will be disqualified when:

- a) They use another athlete's bib;
- b) Damage the bib;
- c) Do not have the bib placed in the chest area, as poor placement of the bib implies a possible failure to obtain results;
- d) Folding the bib in such a way as to reduce its size;
- e) Not wearing their bib throughout the course;
- f) Jumping bars either at the start or finish line;
- g) Do not respect the race signs or the instructions provided by the Organization;
- h) Falsifying any element relating to their registration;
- i) Showing physical discomfort or apparent weakness before the start;
- j) Use more than one chip or 2 bibs with different numbers;
- k) Behaving in an unsportsmanlike manner or failing to comply with the rules stipulated in these regulations and the safety and hygiene instructions given by the staff and competent bodies before, during and after the race.

### **Article 15**

#### **Categories**

1. In MIMOSA – Corrida Pela Vida there will only be the Elite Male and Female categories and the participants who sign up for the collective prizes in dispute.

### **Article 16**

#### **Race certification**

1. The timing system and respective classification will be carried out using the "My Laps" system, whose electronic base will only work if the athlete duly affixes their official bib.



### **Article 17**

#### **Homologation of the rankings**

1. The classifications will be considered definitively approved 15 (fifteen) days after the day of the race.
2. There will be an independent classification by gender and a prize will be awarded for the overall classification up to third place.

### **Article 18**

#### **Money Prizes**

1. There are individual cash prizes, as shown in the table below:

### **Article 19**

#### **Other awards**

1. There will be trophies for the top three (3) male and female finishers in the overall standings. There will be special prizes for the winning teams of the collective prizes in dispute. All classified athletes will receive an official medal and other souvenirs related to the race.

### **Article 20**

#### **Equipment collection**

1. There will be no collection of equipment for participants in the race.

### **Article 21**

#### **Sports insurance**

1. The organization will provide medical assistance throughout the race and at the finish line, where a hospital tent will be set up.
2. Without prejudice to the previous paragraph, the MCP provides nominal sports insurance for all participants, by means of a contract signed with an insurance company, in accordance with the legal framework for compulsory sports insurance set out in Decree-Law no. 10/2009 of January 12, for which purpose they will benefit from the minimum insurance cover provided for in the law.



3. In the event of an accident, claimants should contact the MCP via email at [geral@maratonaportugal.com](mailto:geral@maratonaportugal.com) so that they can fill in the Accident Form to be sent to the insurer by the MCP.

## Article 22

### Data protection measures

1. The MCP will treat the Athletes' personal data for the following purposes
  - a) regular development of the Race;
  - b) elaboration of tables of results/classifications;
  - c) sending important information about the participation in the Event;
  - d) validation of the sports insurance;
  - e) marketing actions of the MCP;
  - f) communications of future similar events; and
  - g) marketing actions by partners/sponsors.
2. The information on how the MCP processes personal data and on your rights is set out in Appendix 1 to these Regulations and in the registration form, of which it is an integral and inseparable part.

## Article 23

### Term of Responsibility

1. The athletes, when registering in the race, sign a liability waiver, with the following content:
  - "1. I have read and agree with the Rules of the MIMOSA – Corrida Pela Vida, available on the official website of the race;*
  - 2. I am aware that I am physically fit to take part in the race*
  - 3. I declare that I will refrain from taking part in the Event if my physical condition changes after I have registered in it and that I will immediately leave the event as soon as I detect signs of weakness and/or indisposition*
  - 4. In case of emergency I authorize medical assistance in the Event and, if necessary, emergency transport to a hospital.*
  - 5. I am aware of the contents of the insurance policy in force, and I have read its specifics, as stated in the Race Rules;*
  - 6. I participate in the Event of free and spontaneous will, exempting MCP, partners, directors, collaborators, and other companies connected to the organization of the Event, of any responsibility resulting from my participation in the Event, before, during or after the Event (namely in case of loss of personal belongings by theft or other circumstances)".*



#### **Article 24**

### **Doping Control**

1. There will be no doping control at MIMOSA – Corrida Pela Vida

#### **Article 25**

### **Cancellation due to Force Majeure**

1. The cancellation of the Event may occur due to reasons of force majeure, alien to the MCP.
2. For the application of the present Regulations, "force majeure" is understood as all unforeseeable or unavoidable events, whose effects occur regardless of the will or circumstances and which the MCP is not capable of justifiably preventing or resisting, including namely acts of hacking, computer viruses, earthquakes floods, storms, cyclones, electrical discharges (natural or network), fires, lightning or explosions and other natural disasters, acts of war and terrorism, social disturbances, fuel and energy shortages and pandemics with serious impact on public health, and general compulsory confinement decreed by the competent public authorities.
3. If the postponement of the Event is determined, the MCP guarantees the automatic transfer of the entries of all athletes to the new proposed date.
4. If the event is cancelled due to force majeure, there will be no refund of the registration fee.

#### **Article 26**

### **Alteration of the Race Course**

1. The MCP may, in exceptional cases, have to change the Race Course, namely, the starting and/or finishing place, as well as the Race Schedule.
2. Exceptional cases" are understood as any factuality that prevents the accomplishment of the Event in the exact terms foreseen in these Rules, that are considered as "force majeure", as defined in the previous article, but that do not generate the cancellation of the Event.
3. If the course of the Event is changed in exceptional cases, there will be no refund of the entry fee.

#### **Article 27**

### **Prohibited Objects**

To preserve the safety of the Event, athletes shall not be allowed to participate on bicycles, accompanied by animals, skateboards, roller skates, scooters, or any other





motorized or wheeled devices. Athletes may not carry or bring with them prohibited objects or substances susceptible to generating or enable acts of violence.

### **Article 28**

#### **Doubts and Complaints**

1. Complaints should be sent to [info@maratonaportugal.com](mailto:info@maratonaportugal.com)
2. The organization has several platforms to support participants' questions, which should be consulted if necessary.

Any cases not covered by these Regulations will be resolved by the Technical Director of the Race, in accordance with the legislation and regulations in force.
